

# **The statutes of public beneficial company Chance for education, public beneficial company**

## ***Introductory provisions***

Public beneficial company was established by the founding c in the form of a notarial record on 20<sup>th</sup> of February 2009

## ***Name of the public beneficial company***

Public beneficial company is in the register of public beneficial organizations registered under the name Chance for education (Šance na vzdělání, o.p.s.)

## ***Company Head Office***

Company Head Office is in Škroupova 631, Hradec Králové, 500 02.

## ***Founder***

The only founder of the company is Centrum andragogiky, Ltd., with its Head Office in Škroupova 631, Hradec Králové 2, 500 02, identification number 27489698, registered in the Commercial Register kept by the Regional Court in Hradec Králové in the section C, number of insertion 22067.

## ***Scope of services***

### ***Duration of the Company***

The Company is established for an indefinite period.

### ***Method of publishing an annual report on the activities and performance of the company***

The company publishes an annual report on the activities and performance of the company on its website.

a) public education, and in particular:

- The organization of open courses, events and workshops focused on the issue of equal opportunities, corporate social responsibility, work-life balance, etc.
- Education aimed at improving knowledge and skills of the elderly,
- Consulting services in the field of education,
- The creation of and operation of information websites
- Publication of promotional materials for the purpose of information and education;

b) international cooperation in the field of education, namely:

- Transfer of know-how, methods and procedures,
- Organization of cultural, sporting and social events,
- Development of tourism and interest in knowledge;

The Company may perform community service in addition to the provision was based, as well as other activities ("Additional Activities"), provided that the additional activity will be achieved through more efficient use of assets while not compromising the quality, range and availability of community services.

Subject matter and scope of supplementary activities of public beneficial company (manufacturing, trade and services) not included in the enclosure 1-3 of the Trade Act, namely:

- a) non-formal education and training, courses, training courses, including teaching,
- b) operation of arts, cultural, educational and entertainment facilities, organization of cultural and entertainment events, exhibitions, fairs, shows, and similar events,
- c) advisory and consulting services, expert studies and reports,
- d) advertising, marketing, media representation;

### ***Value of a indications property contributions of the founder***

- 1) The monetary contribution of the sole founder of the company is 20.000, - CZK (twenty thousand Czech crowns).
- 2) All monetary contribution of the sole founder of 20.000, - CZK (twenty thousand Czech crowns), the founder undertakes to repay before the application for company registration by the register of public beneficial organizations, but not later than 1 (one) month from the date of signature of this foundation Charter, passing into the hands of the administrator of the deposit. The administrator of the deposits is the founder.
- 3) Paid deposit becomes the property of the public benefit company at the date of a registration of the public benefit company in the register of public beneficial organizations.

### ***Management Board***

The Board is the statutory body with three members.

### ***Managing Director***

Managing Director ensures the current operation of the company

### ***Representing the company in external and acting in the name of the company***

- 1) The company outwardly represents and acts on behalf of either the Chairman alone, or two board members jointly.
- 2) The Director is entitled to represent and in the name of the company act without any special authority in all matters relating to ordinary activities, including contracts concluding and commitments intake.
- 3) Signing on behalf of the company happens so that to the written or printed the full name of the company is appended the chairman alone, or two board members jointly or Director's signature.

### ***Supervisory Board***

The Supervisory Board is the supervisory authority of the public beneficial company. The Supervisory Board of public beneficial company has three members.

### ***Principles of economy a property of public beneficial company***

- 1) Public beneficial company is managed by approved economy plans and budgets.
- 2) Asset of public beneficial company is in its possession.
- 3) Sources of public beneficial company asset of the company are:
  - a) existing asset
  - b) property acquired by purchase, self-management,
  - c) donations, grants or other contributions from the state, municipalities and other legal entities and individuals,
  - e) other sources.

### ***The provisions on the settlement of property upon dissolution of a public beneficial company***

In the case of termination of a public benefit corporation is its property asset transferred to the asset of Centrum andragogiky, s.r.o., Škroupova 631, 500 02 Hradec Králové (founder).

### ***Final provisions***

The legal status of the company is governed by the law of the Czech Republic, its of public binding legal regulations, namely in matters not regulated in this foundation charter in particular by the relevant provisions of the Law on Public Benefit Corporations.
